Exhibitor's Contract

Exhibitor's booths are available at the Anderson County Fairgrounds on a first come first serve basis, paid in advance with signed contract.

Fair Booths (8' x 8') are available for \$250 per booth to all vendors. A maximum of two (2) booths will be allowed per vendor. NO EXCEPTIONS

Booth Worker Passes:

- 2 passes per night or 12 passes total per booth will be provided. Additional passes can be purchased at \$5.00 per individual pass, or \$20.00 per season pass.
- All worker passes must be picked up and signed for by a booth representative prior to the opening of the fair. The designated times and location for pass pick up will be announced and posted at the fair office and at the entrances to the Exhibit Buildings the week before the fair opens. NO EXCEPTIONS
- Any booth worker / vendor that does not have a pass will be required to pay gate admission. NO EXCEPTIONS

General Information

- **6' Tables - \$25 per week rental.** Chairs are not available for rent.
- **Booth Registration:** Payment must be submitted with the application.
- **Cancellation Date:** July 1st. Monies paid will not be refunded after that date.
- **Set Up / Tear Down Schedule:**
 - Set up is Saturday, July 13th from noon – 4:00pm, Sunday, July 14th from noon – 4:00pm, and Monday, July 15th from 8:00am – 10:00am. No set-up will be allowed after 3:00pm on Monday, July 15th.
 - Tear down is Sunday, July 21st from noon – 4:00pm. No tear down will be allowed prior to the close of the Fair on Saturday, July 20th. NO EXCEPTIONS
- **Give-Aways:** No water or any drink give-away is allowed due to fairness of the Anderson County Fair's official drink sponsor – Coca-Cola.
- **Security:** A guard will be present on the fairgrounds beginning Friday, July 12th and will remain on the grounds until the conclusion of the fair.
- Booths will remain set up for the entire fair, no early break down. NO EXCPETIONS
- Vendors are responsible for leaving spaces clean, and trash should be placed in the various trash receptacles on the fairgrounds. Recycling is encouraged and recommended.
- Parking for Vendors is available in all regular fair parking lots. No designated vendor-only parking areas are available. The Parking area at the rear of the Old Armory Building (Gate #5) is designated for Handicap Parking Only.
- For the safety of fairgoers, NO VEHICLES will be allowed in the Food Court area after 4:45pm each day. NO EXCEPTIONS
- Exhibit Buildings hours are from 5:00pm – 10pm each night: except on Wednesday the buildings open at 12:00 noon.
